Scholarship Policy

1.Introduction

Government Autonomous College, Angul endeavours to realize the full potential of its students by providing them high quality, accessible, ethical and value-based education to all students in tune to the vision of this HEI - "To Achieve Excellence in Education, Innovation and Service". To ease the financial challenges faced by the students coming from socially and economically disadvantaged strata of the society, Government Autonomous College, Angul has a broad based and all-encompassing Scholarship Policy under different schemes of the Government. The Scholarship Framework at Government Autonomous College, Angul is designed to provide timely, transparent, and effective support to students in accessing various scholarship opportunities. The college facilitates a range of scholarships such as the Post Matric Scholarship for economically disadvantaged students, U.G. Merit Scholarship for academic excellence, Vyasakabi Fakirmohan Bhasabruti for Odia UG and PG students, and the Gopabandhu Sikhya Sahayata Yojana for marginalized communities. Nirman Shramik Kalyan Yojana for children of construction workers, the Post-Matric Scholarship for Students with Disabilities, the Biju Yuba Sashaktikaran Yojana (Laptop DBT) for meritorious students, Junior Merit Scholarship for outstanding first and second-year students. As this college aspires to impart quality education, equity to all the aspiring students, these scholarships promote an outstanding academic environment apart from other possible academic support for the holistic growth of students. The above stated scholarships

are open to all category of students enrolled in various programmes offered by this HEI based on their eligibility criteria.

3. Role of this HEI to facilitate the award of scholarships

3.1 To make sure that each student is aware about various scholarships offered, their eligibility criteria and financial assistance to be provided, massive awareness campaign is carried out by means of advertisement in notice board of each department, libraries, students common rooms, canteens, hostels, and other conspicuous places of the college campus, through college website, through social media posts and messages in students social media groups.

3.2 To make sure that not a single eligible student is left behind and to get maximum number of applications, this college provides handholding support to

students through counselling of students about eligibility criteria, collection of required documents to filling up the forms through dedicated group of nodal officers for each department.

3.3 To validate the application forms submitted by students in the scholarship portal strictly as per Govt. guidelines this college assigns group of nodal officers who vet each application so that not a single eligible student is exclude and not a single ineligible student is included.

4. Mode of awarding scholarship:

- Award of scholarship to students goes through a robust and transparent process.
- First a massive awareness campaign about each scholarship offered is conducted through various IEC (Information, Education and Communication) activities to reach out to each and every student of this HEI.
- Then through various teams formed to support the students from getting the required documents to filling up the forms, application received from all students for every scholarship offered.
- Nodal officers assigned for each scholarship scrutinise and validate each application and forward the application of all eligible students to the concerned departments of Govt. of Odisha and Govt. of India for award of scholarship.
- After selection the scholarship amount is directly credited to the students` bank account through DBT (Direct Benefit Transfer).

5. Number of awardees:

Number of awardees varies from year to year and scholarship to scholarship as per the guidelines of Govt. of Odisha and Govt. of India and eligibility of the students.

6. Amount of scholarship:

Amount of scholarship varies from year to year and scholarship to scholarship as per the guidelines of Govt. of Odisha and Govt. of India and eligibility of the students.

7. Types of scholarships

A. State Scholarship

i. Post-Matric Scholarship

Eligibility Criteria

Educational qualification: Intermediate/+2 and enrolled in any UG programme with minimum 50% marks.

Category- Open to all category

Income- Parents/ guardian's from all sources shall not exceed Rs. 250000.00 (Two Lakh Fifty Thousand) per annum.

ii. E-Medhadruti

a. UG- merit

Educational qualification- Minimum 55% in last exam appeared

Eligibility - All UG courses

Category - Open to all category

Income- Parents/ guardian's from all sources shall not exceed Rs. 800000.00 (Eight Lakh) per annum

b. PG- merit

Educational qualification- Minimum 55% in last exam appeared

Eligibility - All PG courses

Category - Open to all category

Income- Parents/ guardian's from all sources shall not exceed Rs. 800000.00 (Eight Lakh) per annum

c. Technical and Professional merit

Educational qualification- Minimum 55% in last exam appeared

Eligibility - Master in Computer Application (MCA), Master of Business Administration (MBA)

Category - Open to all category

Income- Parents/ guardian's from all sources shall not exceed Rs. 800000.00 (Eight Lakh) per annum

iii. Nirman Shramik Kalyan Yojana

Eligibility - All UG and PG courses

Category - Open to all category

Income- NA and must be wards of construction workers

iv. **Gopabandhu Sikhya Sahayata Yojana**

Eligibility - All UG and PG courses

Families impacted by HIV/AIDS, homeless, houseless families, Transgender, Bonded Labour, Vulnerable Tribal groups, Single Mother, Specially Cared Child, Girls students rescued from child marriage.

Category - Open to all category .

Income- Parents/ guardian's from all sources shall not exceed Rs. 250000.00 (Two Lakh Fifty Thousand) per annum.

v. **Vyasakabi Fakirmohan Bhasabruti**

Educational qualification- For UG - 60% in Plus 2 and PG - 60% in Odia (Honors) in UG

Eligibility - All UG and PG courses

Category - Open to all category

Income- Parents/ guardian's from all sources shall not exceed Rs. 250000.00 (Two Lakh Fifty Thousand) per annum.

vi. **Biju Yuva Sashaktikaran Yojana**

Category- All

Courses- UG 1st year

B. National Scholarship

i. Central Sector Scheme of Scholarship for College and University Students

Courses - All UG and PG

Eligibility-

- Students who are above 80th percentile of successful candidates in the relevant stream from a particular Board of Examination in Class XII.
- Having family income up to Rs. 4.5 lakh per annum.

ii. Financial Assistance for education to the wards of beedi workers

Courses - UG Courses and professional courses.

Eligibility-

- Either of the parents of the students should be Beedi worker with at least six months service. This also includes Contract/Gharkhata (Home Based) workers also.
- Total monthly Income of the Worker's family from all sources should not exceed as under: - Beedi Workers - Rs.10,000/-

iii. Post- Matric Scholarship Scheme for Minorities

Courses- All UG and PG

Eligibility-

- Scholarship will be awarded to the students who have secured not less than 50% marks or equivalent grade in the previous final examination.
- The annual income of parents/guardians from all sources does not exceed Rs.2.00 lakh.

iv. Post-Matric Scholarship for Students with Disabilities

Courses- All UG

Eligibility-

- All the components of scholarships are open to students with benchmark disability i.e. 40% or more disability.
- Must have UDID enrolment.

v. National Scholarship for Post Graduate Studies

Courses- All first PG Degree programme only.

Eligibility-

- Student must be below the age of 30 years of age to apply under these schemes.
- Admitted to PG degree programme through 'Regular/Full Time' mode.

8. Conclusion

It is the mission of this HEI to facilitate financial support provided by the state and central Government to all eligible students. Awareness campaigns are to be organised to encourage more students for submission of application. Students' participation in scholarship programme in this institution is quite encouraging, but still, we hope for greater achievement in future.
